# TRAVEL IDENTITY CARD

The police will issue a travel identity card upon request, if: • you do not have a valid travel document and cannot obtain one in any other way

• you are under 15 years of age and have been hospitalised

# Validity:

• max. 6 months • cannot be extended

The police will issue a travel identity card without a request, if:

- you are staying on the territory without a valid travel document after your short-term visa has been declared invalid
- a judgment imposing the sentence of your expulsion became effective and you have no other travel document

# The Ministry of the Interior will issue a travel identity card upon request, if:

- you have a long-term residence permit, do not have a valid travel document and you cannot obtain one (maximum validity is 180 days)
- you have a long-term visa or a long-term residence permit for the purpose of leave to remain on the territory and you are staying on the territory without a valid travel document (maximum validity is 365 days)
- The Ministry will issue a travel identity card without a request,
- if:
- you are staying on the territory without a valid travel document
- after a judgment cancelling the validity of a long-term visa, long-term residence permit or permanent residence becomes effective
- after the expiry of a permanent residence permit
  after the issue of a visa for the purpose of leave to remain
- after the issue of a visa for the purpose of leave to remar



# PERMANENET RESIDENCE PERMIT On The TERRITORY Of The CZECH REPUBLIC

- You Can Apply, if You Are:
- a third country national
  after five years of continuous residence
- without the condition of former continuous residence on the territory
- for humanitarian reasons
- for reasons worth special consideration
- if your stay on the territory is in the interest of the Czech Republic
- if it concerns a minor or an adult dependent child of a foreign national who
- is staying on the territory on the basis of a permanent residence permit,
- if the reason of such application is family reunification of these foreign nationals
- following the termination of international protection proceedings (in cases set by law, within 2 months after the termination of the proceedings for granting international protection)

#### Where to Apply:

- at an Interior Ministry office according to your place of residence
- at a permanent diplomatic mission of the Czech Republic

#### **Requirements for Application:**

- a completed application form
- a travel document
- 2 photographs
- evidence of funds to cover the permanent residence on the territory (NOT in cases stipulated by law)
- if you are under 18 years of age consent of one of your parents, statutory representative or a guardian with your stay
- a document proving that you have accommodation in the Czech Republic
  a document certifying the required knowledge of the Czech language
- (NOT in cases stipulated by law)
- a document proving the purpose of stay on the territory (NOT if you are applying after 5 years of residence)
- a document issued by a foreign state which is similar to an extract from the Register of Criminal Records (NOT for persons under 15 years of age or in cases stipulated by law)

#### Validity:

• 10 years (5 years for children under 15 years of age)

#### **Processing Time:**

- 60 days from the date of filing in the Czech Republic
- 180 days from the date of filing outside the Czech Republic

#### Administrative Fee:

• CZK 2,500 (CZK 1,000 for children under 15 years of age)

After the period of 2 years of continuous temporary residence on the territory, you can apply for a permanent residence permit if you are, for at least one year, a family member of a national of the Czech Republic who has permanent residence on the territory, or if you are a family member of a national of another EU Member State who had been issued a permanent residence permit on the territory (the law stipulates what is needed for the application).

# CHANGE IN THE SCOPE OF COMPETENCE IN CONNECTION WITH THE AMENDMENT OF ACT no. 427/2010 Coll., ON THE RESIDENCE OF FOREIGN NATIONALS

An essential change is the transfer of all residence issues and paperwork related with the issuance of long-term visas to the competence of the Ministry of the Interior of the Czech Republic.

The following authorities are active in the area of residence of foreign nationals on the territory of the Czech Republic:

# Foreign Police

Ministry of the Interior

*Ministry of Foreign Affairs* – issuance of permits for the residence of foreign nationals using privileges and immunity based on international law

# Foreign Police Decides on:

- denying entry to a foreign national onto the territory and cancelling the validity of a visa
- detaining a foreign national for the purpose of administrative expulsion, covering costs related to administrative expulsion, placing a foreign national into a facility
- extending the period of residence for a short-term visa, on termination of temporary residence and issues a departure order
- cancelling the validity of a short-term visa
- administrative expulsion, imposing an obligation to leave the territory, imposing a special provision for the purpose of leaving the territory
- placement of a foreign national in a facility
- performs a residence check

#### Interior Ministry Decides on:

- the issuance of a permanent residence permit and its extension
- the issuance/withdrawal of an Alien's passport
- acknowledgement/cancellation of the status of a holder of a long-term residence permit
- the issuance, cancellation, extension of Green Cards

# <u>CHANGES IN HEALTH INSURANCE</u> FOR FOREIGNERS FROM 1 JAN UARY 2011

The possibility of immediate insurance is eliminated (except for tourist visas up to 90 days). If public health insurance in the Czech Republic does not apply to you, you must be insured COMPREHENSIVELY with a coverage limit of at least EUR 60,000. Comprehensive care does not include dental examinations (only in an acute case), etc. – READ THE INSURANCE EX-CLUSIONS CAREFULLY at individual insurers!!!

- This insurance must cover the full duration of your stay and can be negotiated only with an insurer authorised to provide such insurance for the territory of the Czech Republic:
- If you submit a residence application from abroad, you can insure yourself at an insurer that:
- also operates in other member states of the European Union or in a state bound by the Treaty on the European Economic Area (Iceland, Liechtenstein, Norway)
- operates in a state of which you are a citizen or in which you have been granted residence
- Together with proof of travel health insurance, you must also present a certified translation into Czech of the insurance contract and the general terms and conditions of insurance.
- Proof of payment of the insurance premium must be presented with the residence application. If you are not granted residence, certain insurers will refund the unused portion of the premium to you (Slavia, Maxima, Uniqa with a 20% cancellation fee).

- Every insurer has the right not to insure you.

# **BIOMETRIC DATA**

facial image and fingerprints

- this applies only to nationals of third countries
- taken only by selected offices of the Ministry of the Interior

#### **Obligatory when applying for:**

- a long-term residence permit or its extension
- a permanent residence permit
- the issuance of a Green or Blue Card
- the issuance of a new residence permit card

#### Administrative Fees (in the form of fee stamps):

- CZK 2,500 (CZK 1,000 for children under 15 years of age) for the issuance of a residence permit card or extension of its validity
- CZK 1,000 for a change in a residence permit card
- CZK 4,000 (CZK 2,500 for children under 15 years of age) for the issuance of a residence permit card as a replacement for a damaged, destroyed, lost or stolen residence permit card or residence permit card with a non-functional storage medium.

# **ALIEN'S PASSPORT**

#### You can apply if:

- you have permanent residence and do not have a valid passport and you prove that you cannot obtain one
- you are under 15 years of age and you stay in the Czech Republic on the basis of a decision on your placement in foster care
- you have been granted subsidiary protection and do not possess a travel document
- $\bullet$  you have been provided temporary protection and you have no travel document

#### **Requirements for Application:**

- a filled-in form
- 2 photographs in the case of a foreign national's passport with no biometric identifiers

## Where to Apply:

• at an Interior Ministry office according to your place of residence

#### **Processing Time:**

- 30 days from the date on which the application was filed
- 15 days from the date on which the application was filed without biometric identifiers

## Validity:

- 10 years
- 5 years for children under the age of 15
- based on the validity of the card of the person that has been granted subsidiary or temporary protection
- 6 months without biometric identifiers
- validity cannot be extended
